Context – What is BEDD

BEDD is a Total Available Market (TAM) database. It counts and forecasts buyer and/or users in the Private and Public Sectors. TAM units can be Employees, Business or Government entities, or sites/locations. The TAM for a product or services in the Public (Government) and Private Enterprise Sectors are defined by the product or service produced and offered to the buyers and users of those products and services, i.e., industries and government entities, as well as the size of those business and agencies. **BEDD** was designed to help clients size and forecast the total available market for their products and services. It provides the answer to three fundamental planning questions.

- 1. How big is the market for your product or service?
- 2. How fast or slow is it growing?
- 3. How is it segmented by Sector, Sub-Sector, Industry and Business Size?

Challenges and Assumptions

The Next Shock

Most credible recognized economists are of the opinion that the Trump administration's stated economic and domestic policies will lead to an inflation, significant unemployment, and a recession. The unknown is the degree to which Trump will actually attempt to execute his plans, and the degree to which the legislature, the courts, and other economic actors can mitigate or block those plans.


Given the current uncertainty we applied an approach that attempt to quantify the range of possible outcomes given the data and information currently available, To accomplish this, **DRG** has developed three forecasts representing different assumption,


The Base Forecast – This forecast is based on economic conditions and trends prior to the announcement and implementation of the current administrations Tariffs on April 2nd, 2025. The forecasts is based on the March CBO 10-Year employment forecast, the September 2024 BLS 10-Year forecasts, the 1998-2022 data from the Census Bureau SUSB data base, and the April BLS Jobs reports and data. While this forecast is obviously obsolete, its usefulness is as a base to measure the changes in the US Business Economic Demographic Structure caused by Tariffs and Deportations. This forecast does assume a reduction in the Federal Workforce of 400,000 employees



The Mass Deportation Forecast – Assumes 100% of all undocumented immigrant employees are deported in 2025. While this is an impossible scenario because the deportation infrastructure and process does not exist and could not be fully implemented this year, there is value is defining this extreme scenario to bound the range of alternative possible deportation scenarios.

Based on our research the following presents our assumption as to the percent of employees in each industry that are undocumented immigrants and would be deported.
